STATUTE-13

(As amended upto November, 2009)

1. <u>Short title and commencement;</u>

- (1) This Statute may be called the Rajiv Gandhi Proudyogiki Vishwavidyalaya (Board of Studies) Statute, 2007;
 - (2) This shall come into force with effect from the date of publication in the Madhya Pradesh Gazette.
- 2. **<u>Definitions</u>**; In this statute, unless the context otherwise requires;
 - (a) **"Adhiniyam"** means the Rajiv Gandhi Proudyogiki Vishwavidyalaya Adhiniyam 1998, (No 13 of 1998);
 - (b) **"Statute"** means the Statute made under the provisions of Section 37 and 38 of the Rajiv Gandhi Proudyogiki Vishwavidyalaya Adhiniyam, 1998 (No 13 of 1998);
 - (c) **"Section"** means Section of the Adhiniyam;
 - (d) **Words and expression** used but not defined in this statute shall have the meaning as assigned to them in the Adhiniyam.
- 3. There shall be a Board of Studies for degree and diploma for each of the subjects or groups of subjects mentioned in column (2) of the table below under the faculty mentioned in column (1) thereof –
